OSHA FINES CONTRACTOR AFTER FATAL FALL GOES UNREPORTED

OSHA has fined a Newark, N.J., roofing contractor for failing to report the death of a worker who suffered a fatal fall at a construction site. On March 27, construction crews from Jose Construction Corp. were working on the roof at a Flushing, N.Y. location when a worker fell 20 feet from a ladder. The man died of his injuries days later, according to OSHA.

A federal investigation began on April 26 after a third party notified OSHA about the death, the *TimesLedger* (Queens, N.Y.) reported.

Federal investigators are also fining the contractor for fall hazards.

Upon inspecting the site, investigators found the 20-foot extension ladder did not extend three feet above the roof's edge as required, according to OSHA. The ladder also lacked a grasping device, and employees were carrying bags of tools while climbing the ladder and were not properly trained in ladder use, OSHA said.
